MARYLAND LAUNCHES HEALTH INSURANCE CONSUMER ASSISTANCE PROGRAM TO READY RESIDENTS AND SMALL EMPLOYERS FOR OPEN ENROLLMENT THROUGH [MARYLAND HEALTH CONNECTION](#)

Maryland Health Benefit Exchange selects Healthy Howard to educate and enroll uninsured residents and small employers in Western Maryland

BALTIMORE (April 25, 2013)—The [Maryland Health Benefit Exchange](#) (MHBE), the public corporation and unit of Maryland State government responsible for the implementation of the state-based insurance exchange through the Affordable Care Act, announced today the launch of its Connector Program with the award of an anticipated \$24 million in grant funds to six organizations serving as consumer assistance and enrollment resources throughout the state. Healthy Howard, Inc., a 501(c)(3) non-profit organization based in Columbia, will serve as the prime grantee for a period of 12 months beginning July 1st to meet the needs of individuals and small employers in Howard, Carroll, Frederick Washington, Allegany and Garrett Counties through outreach and education, eligibility determination and enrollment into Medicaid and qualified health plans. The regional approach ensures that the needs of Maryland's uninsured and underserved communities are provided with in-person assistance as the new health insurance coverage options become available in October 2013 through Maryland Health Connection, the state-based health insurance marketplace.

Healthy Howard, Inc. will receive an anticipated \$3.3 million in grant funding to provide education, outreach, eligibility and enrollment services for the nearly 85,000 uninsured residents in the counties it serves. The intent of the regional approach is to ensure that all populations are reached including those with limited English proficiency, disabilities or those that may be in underserved communities. Healthy Howard, Inc.'s Door to HealthCare has developed a collaborative approach with 12 subcontracting partners to provide services, including:

“I’m proud to announce this important investment in Maryland’s health care system,” said Lt. Governor Anthony Brown. “By working together to implement the Affordable Care Act, we aren’t just helping Marylanders get the care they need, we’re also creating over 300 jobs across our state.”

“Creating a customized outreach program for each region will allow the navigators to address the specific needs and resources of Marylanders throughout the state.” said Dr. Joshua M. Sharfstein, Secretary of the Department of Health and Mental Hygiene and chair of the Board of the Maryland Health Benefit Exchange.

Healthy Howard, Inc. will employ a workforce of 57 navigators and assisters to provide outreach and education, with a particular focus on hard-to-reach populations. Trained and certified navigators will counsel and enroll residents into qualified health plans and Medicaid through Maryland Health Connection, the state-based insurance marketplace scheduled to open on October 1, 2013. Non-certified personnel, known as “assisters,” will be trained to provide information, assistance and enrollment into Medicaid. Navigators and assisters will provide information about eligibility requirements for federal premium subsidies and cost-sharing assistance, and assess eligibility requirements for Medicaid and Maryland Children’s Health Program.

“As the Connector Entity for Western Maryland, we look forward to working closely with our partners and building upon our work to improve access to affordable health care,” said Christine Hall, Executive Director of Healthy Howard, Inc. “We are eager to serve in this capacity so that all Marylanders who need health coverage throughout the region will be able to get hands-on help to find a plan that meets their needs.”

“Healthy Howard has been an innovator in health care outreach and will be a strong partner in the Connector Program,” said Rebecca Pearce, Executive Director of the Maryland Health Benefit Exchange. “The partners they have identified for this program will ensure that the needs of those with disabilities and language barriers in some of the most remote areas of the state are met appropriately and with care.”

Navigators and in-person assisters will provide referrals to appropriate agencies, including the Attorney General's Health Education and Advocacy Unit (HEAU) and the Maryland Insurance Administration (MIA) for applicants and enrollees with grievances, complaints, questions or the need for other social services through the Department of Health and Mental Hygiene and the Department of Human Resources (Social Services).

About Maryland Health Connection: Maryland Health Connection is the marketplace for individuals, families and small businesses to compare and enroll in health insurance, as well as determine eligibility for Medicaid and other assistance programs, federal tax credits and cost-sharing reductions. Enrollment through Maryland Health Connection is scheduled to begin in October 2013, with insurance coverage beginning January 1, 2014. An estimated 180,000 individuals are expected to enroll in qualified health plans (QHPs) during the first year. www.MarylandHealthConnection.gov
