Welcome & Introductions – John Pierre Cardenas, Manager, Individual and Small Group Marketplace Programs

Meeting minutes approved

There was a motion to approve the meeting minutes from January by John Fleig, of United Healthcare, and seconded by Sandy Walters of Kelly & Associates Insurance Group.

Feedback from the field

No feedback was received from committee members.

Membership Changes

John Pierre shared with the committee that the 2017 Plan Management Stakeholder Committee roster would be posted to the website.

Open Enrollment Wrap-Up - John Pierre Cardenas, Manager, Individual and Small Group Marketplace Programs

John Pierre shared the following facts and figures with the committee:

- Total number of QHP enrollments 153,637
- Total number of SADP enrollments 51,218
- The most enrollments came from Montgomery County followed by Prince Georges County
- Market share by carrier: CareFirst = 64%, Kaiser = 35%, Cigna = 1%
- The use of the new mobile application was strong and exceeded expectations

Supplemental Maryland Reinsurance Program (SMRP) - John Pierre Cardenas, Manager, Individual and Small Group Marketplace Programs

John Pierre shared the following regarding 2016 SMRP :

- Operational guidance on the 2016 SMRP will be released February 17, 2017;
- The timeline that was used for 2015 will be followed;
- Total reinsurance amounts will be included in the guidance.

Carrier Testing – Technology Migration - John Pierre Cardenas, Manager, Individual and Small Group Marketplace Programs

The following was shared with the committee:

- Regression testing and renewals testing schedules

- MHBE will provide scenarios to carriers by 2/17/17 for review and feedback
- Carriers will need to provide feedback by 2/24/17

John Pierre explained to the committee that a work group would be formed to assist with the creation of Standardized Benefit Design. Committee members were informed that applications for those interested in participating would be available on MHBE's website by February 3.
