Your Kidney Disease Program (KDP) card **must be shown to your health care provider at all times whenever you receive medical care for your end-stage renal disease.** Parents/Caretakers should present this card for children who are eligible to receive services.

If you have **MEDICARE, Maryland Medical Assistance and/or private insurance, present ALL of your insurance cards with your KDP card to providers of service.** If you have a prescription card from a private insurance company, Medicare, Medical Assistance or union, **present your prescription plan card with your Kidney Disease Program card when you have your prescription(s) filled.**

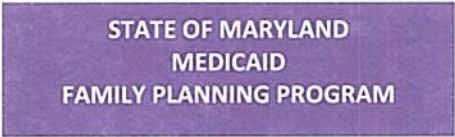

- You may lose Medicaid benefits if your information is not up to date. You must report changes within 10 days. Examples include change of address, job status and income, pregnancy, marriage, or divorce. To report changes call the Family Planning Program Eligibility Unit at 1-855-692-4993.
- To apply for full Medicaid coverage, call Maryland Health Connection at 1-855-642-8572
- You are the only one who can use this card. Unauthorized use of this card may result in criminal prosecution.
- Report suspected fraud or abuse to MDH Office of the Inspector General at 1-866-770-7175.
