1) Key Information Summary Sheet Amended to reflect the following:

2) Section 2.1 Purpose Amended to reflect the following:

The purpose of this solicitation is to renew the subscription to Zephyr Scale Test Management for JIRA Data Center for a 12-month duration as stipulated in Section 2.2.

3) Section 2.2 Requirements Amended to reflect the following:

The vendor shall provide MHBE the following JIRA component for a 12-month starting November 29, 2025, through November 28, 2026:

4) Section 2.4 Invoicing Amended with the removal of the following:

MHBE will issue a Purchase Order, for payment, one year at a time considering this is a two-year renewal request. To elaborate, MHBE will issue the payment for the term 2025 – 2026, in 2025; for the term 2026 – 2027, in 2026.

Also, vendors shall divide the payment equally for the two-year term or however, they prepare their pricing on the Bid Price Form (Attachment D). For example, if the total cost for the two-year term is \$200, vendors shall enter \$100 for the first term (2025 – 2026) \$100 for the second term (2026 – 2027).

5) Section 4.1.2 Amended to reflect the following:

Bidders must submit their bids and all required attachments in pdf format to eMMA.

Bidders must submit with their Bid the required minimum qualification documentation (see Section 3), and any required bid submissions (see Section 4.2.4) with one document clearly labeled as “Bid, Zephyr Test and Automation for JIRA Data Center Subscription Renewal # BPM052320” in time to be received by **11:00 AM, Eastern Standard Time** September 17, 2025.
